Online application is called from all eligible Nepalese and Foreign Candidates from October 19, 2021 10:00 AM to November 3, 2021 5:00 PM (NST) through <https://entrance.mec.gov.np>

i.	DM(Medical Specialties) ¹	- MD Internal Medicine or equivalent ² - Specialty Registration in Medical Council of respective country.
ii.	DM Critical Care Medicine ¹	- MD Anesthesiology or equivalent or - MD Internal Medicine or equivalent or - MD Critical Care Medicine - Specialty Registration in Medical Council of respective country
iii.	DM Emergency Medicine ¹	- MD in General Practice and Emergency Medicine or equivalent or - MD Emergency Medicine - Specialty Registration in Medical Council of respective country
iv.	DM Neonatology ¹	- MD Pediatrics or equivalent or - MD Neonatology - Specialty Registration in Medical Council of respective country
v.	MCh (Surgical Specialties) ¹	- MS General Surgery or equivalent ² - Specialty Registration in Medical Council of respective country

¹ This entrance examination is also for NBMS (National Board of Medical specialties) subspecialty programs of this academic year.

² The Candidate with Specialty subject in MD in (For example: MD Cardiology, MD Nephrology etc.) and MS (For example: MS Urology, MS Neurosurgery etc.) shall be eligible only in DM/MCh in respective subject only.

Full marks for all programs will be 200 with pass marks 50% and duration of examination will be three hours.

Exam center and date of entrance examination will be published later.

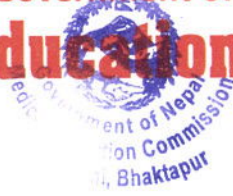
Note: There is provision for editing application and saving file before submission. Application once submitted cannot be edited. However, Applicants can apply fresh all over again by uploading new bank voucher.

2. Procedure and Instruction for Online application

- The application can **only** be submitted online through <https://entrance.mec.gov.np>
- Applicants can pay the entrance fee in aforesaid account detail of Himalayan Bank Ltd. within the deadline. The bank voucher/payment slip should clearly contains the **transaction number** and **applicants' mobile number**.
- Documents Required:**
 - Last six digits of transaction reference number (TRN) and applicants mobile number.
 - Recent Passport size photograph.
 - Passport or Aadhaar card.
 - Scan copy of Signature
 - Transcript of relevant Master degree or equivalent.
 - Medical Council specialty registration certificate of respective country.
- Students can be expelled any time (even after admission) if found guilty in submitting fake documents and wrong identity.
- Once the application is filled, the necessary documents are to be uploaded and the self-declaration is to be done. It is advised to review (edit/save) the application before submission. Once the application is submitted, it is not editable.
- Application can saved and edited as many times by accessing through "Check your Status" on application portal. Application once submitted can not be edited. Contact number and email address are not editable once entered.
 - Image File Format:** The image must be in the Joint Photographic Experts Group (JPEG) format with good quality.
 - While saving file the image should not be crispy or blurry.
 - Image Resolution:** The photo must be correct orientation and cropped to image area.
 - Image File Size:** The maximum file size is 200 kilobytes(200KB)

- i. **File Format:** JPEG OF Pdf.
 - ii. While saving file the image should not be crispy or blurry.
 - iii. **Image File Size:** The maximum image file size us 500 kilobytes (500KB).
- g) A Confirmation Page will be displayed only after verification of bank payment. You can save/print it for future reference. It is not Admit Card but proof for online Form submission.
- h) Students should print their own admit card by providing details in the “Check Application Status” page which can be visited by clicking “Check your status/print admit card” button in home page. Admit card can be printed before 5 days of entrance examination date.
- i) Candidates will be responsible for all travel arrangements. Candidates should abide by the current rules and regulations laid down by Government of Nepal.

The eligibility for foreign candidates:

- a. It is mandatory for all foreign candidates to submit the application form in due date.
- b. All candidates should score at least 50 percent in the entrance exam to qualify for admission.
- c. If the number of foreign merit candidates is less than the available seats allocated for foreign candidates, matching will be done only once.
- d. The remaining seats henceforth will be transferred to Nepalese open seats.
- e. Foreign candidates who are selected for admission are required to produce original documents during admission.
- f. Foreign candidates who are selected for admission are required to register in Medical Council of respective country before the academic session begins.
- g. Candidates who submit the fake documents will be liable for legal actions as per prevailing rule and regulations of Nepal.
- h. Private practice is not allowed during the residency.
- i. Medical Education Common Entrance Examination Committee reserves all the rights regarding entrance examination.
